NOW THEREFORE, Declarant hereby declares and agrees as follows:

- (1) Declarant hereby declares that the Property shall be held, sold, and conveyed subject to the Covenants. The Covenants shall run with the Property and shall be binding upon all parties having or acquiring any right, title, or interest in the Property. The Owner(s) of any parcel of land constituting the Property shall enjoy all rights and benefits, and be subject to all of the obligations and burdens, of the Covenants. Each parcel of land which is a part of the Property shall constitute a Lot within the meaning of the Covenants.
